

## Letter from a parent of two currently-registered UW students to UW President Goel

Dear Dr. Goel,

I am the parent of two University of Waterloo students, both of whom are currently registered and in excellent academic standing.

We are well aware of the vaccine mandates recently imposed by the university however, I along with many other concerned parents, faculty and students find this 'mandate' not only problematic but illegal and dangerous.

You must have access to the same research, data, and expertise all of which emphasize 1) that the genetic modification therapies are in experimental phases, and 2) the long-term safety data and evaluations are as yet, incomplete.

It is not enough to simply assert that "vaccines are safe and effective" nor that the university is doing its best to "keep people safe". These are slogans that attempt to disguise breaches of ethics, contracts, and law.

Furthermore, the said therapies do not prevent transmission or symptoms of any SARS-CoV-II virions as clearly stated in the manufacturers' reports.

If you do not have this data, I am happy to forward the many publications and bulletins upon your request. See below for links I have included.

In the meantime, \*Public Health Ontario\* recently published reports of myocarditis/pericarditis as adverse events in Ontario following the receipt of a COVID-19 mRNA 'vaccine' highest among young adults.

I encourage you to examine these reports with the knowledge that these adverse reactions, along with many other injuries, are fast becoming common worldwide.

Despite the term "rare" the rate of occurrence is not only unknown but remains unpredictable, hence the use of the term "ongoing evaluation".

As well, \*Health Canada Recalls and Safety Alerts\* have published

warnings on both Pfizer and AstraZeneca products. Surely you remember that public health "experts" in this country and the Prime Minister assured Canadians that AstraZeneca was "very safe and effective". It has since been suspended for use in individuals under 55 years of age.

After you have enthusiastically promoted, threatened, and encouraged all students to "get vaccinated or else", will you as president be personally held liable for any or all injuries sustained thereafter? Time will tell.

Note: The response that you were "just following orders" ceased to be acceptable several decades ago.

A gentle reminder that mandatory vaccination in Canada is still illegal under section 7 of the Canadian Charter of Rights and Freedom.

As such, neither of my children should be coerced or threatened into accepting any type of injection, nor should they be prevented from achieving their academic goals for withholding consent to medical interventions and/or genetic testing. As promising graduates that have put in an incredible amount of hard work not to mention exorbitant tuition fees, they should not have been encouraged to "withdraw" from the university because of fear based public health edicts. There was absolutely nothing in their application or acceptance to the University of Waterloo that referred to their health status as a necessary condition for an undergraduate degree. That would be illegal and discriminatory.

Lastly, as far as I am aware, the University of Waterloo cannot legally deny or prevent my children from attaining undergraduate degrees in their respective fields simply because they do not consent to medical and/or genetic interventions.
